## **INFORMATION AUSLANDSBAU Nr. 02**

### **Informationen über staatliche Beihilfen für Bauinvestitionen in Rumänien**

Sehr geehrte Damen und Herren,

die Botschaft von Rumänien hat uns zu aktuellen staatlich finanzierten Bauprogrammen in Rumänien eine Übersicht zur Verfügung gestellt. Diese Programme bieten finanzielle Unterstützung für Bauunternehmen, die neu in Rumänien investieren oder bereits in Rumänien präsent sind.

Die vier Programme im Überblick:

- 1. ConstructPLUS - Entwicklung der inländischen Produktion von Bauprodukten und -materialien**
  - **Laufzeit:** 2023-2026
  - **Gesamtbudget:** 596 Millionen Euro
  - **Zuständige Behörde:** Ministerium für Wirtschaft, Unternehmertum und Tourismus
  - **Ziel:** Finanzielle Unterstützung von Investitionen zur Errichtung und/oder Entwicklung von Produktionskapazitäten für Bauprodukte und -materialien
  - **Förderfähige Investitionen:** Sachanlagen (Gebäude, Grundstücke, technische Anlagen, Maschinen und Ausrüstungen) und immaterielle Güter (Patente, Lizenzen, Know-how)
  - **Förderfähige Antragsteller:** Start-ups, bestehende Unternehmen, KMUs und Großunternehmen
  - **Maximale Förderung:** Bis zu 50 Millionen Euro, abhängig von der Region und der Unternehmensgröße
- 2. INVESTALIM - Entwicklung und Modernisierung der Lebensmittelindustrie**
  - **Laufzeit:** 2023-2026
  - **Gesamtbudget:** 590 Millionen Euro
  - **Zuständige Behörde:** Ministerium für Landwirtschaft und ländliche Entwicklung

- **Ziel:** Finanzielle Unterstützung von Investitionen in die Entwicklung und Modernisierung der Lebensmittelindustrie
- **Förderfähige Investitionen:** Einrichtung neuer Produktionseinheiten, Erweiterung bestehender Einheiten, Diversifizierung der Produktion, grundlegende Änderung des Produktionsprozesses
- **Maximale Förderung:** Bis zu 57,75 Millionen Euro, abhängig von der Region und der Unternehmensgröße

### 3. GD 959/2022 - Unterstützung von Investitionen in der verarbeitenden Industrie

- **Gesamtbudget:** 300 Millionen Euro
- **Zuständige Behörde:** Ministerium für Wirtschaft, Unternehmertum und Tourismus
- **Ziel:** Finanzielle Unterstützung von Investitionen in die verarbeitende Industrie
- **Mindestinvestition:** 3 Millionen Euro
- **Förderfähige Investitionen:** Einrichtung neuer oder Erweiterung bestehender Produktionseinheiten, Diversifizierung der Produktion
- **Maximale Förderung:** Bis zu 45 Millionen Euro, abhängig von der Region und der Unternehmensgröße

### 4. GD 300/2024 - Regionale Entwicklung durch große Investitionen

- **Laufzeit:** 2024-2026
- **Gesamtbudget:** 450 Millionen Euro
- **Ziel:** Regionale Entwicklung durch Förderung großer Investitionen
- **Förderfähige Investitionen:** Neue Bauten, technische Anlagen, neue Maschinen und Ausrüstungen, immaterielle Güter wie Patente und Lizenzen
- **Voraussetzungen:** Eigenfinanzierungsanteil von mindestens 25 % der förderfähigen Kosten, Investitionen müssen mindestens 5 Jahre nach Abschluss beibehalten werden

## R O M A N I A

### National programs financed from the State Budget

#### ConstructPLUS - development of domestic production of construction products and materials

Period: 2023-2026

Total Budget: EUR 596 million

2024 Budget: EUR 149 million

Authority in charge: Ministry of Economy, Entrepreneurship and Tourism

The program was opened on 8<sup>th</sup> of April 2024

The purpose of the program is the financial support of investments for the establishment and/or development of production capacities for construction products and materials.

The main information about this financing program:

- **Eligible applicants:** start-ups or enterprises in activity, SMEs and large enterprises;
- **The maximum amount of state aid:** up to EUR 50 million, depending on the county where the investment is made;
- **The maximum intensity of state aid:** between 30% - 75%, depending on the county where the investment is made and the size of the enterprise;
- **Types of eligible investments:** investments in **tangible assets (buildings, land, technical installations, machinery and equipment)** and **intangible assets (patents, licenses, know-how or other intellectual property rights)** related to the establishment of a new unit, expanding the capacity of an existing units, diversification of a unit's production;
- **There is a list of eligible manufacturing fields of products** that can apply for this program.

## **INVESTALIM - development and modernization of the food industry**

**Period: 2023-2026**

**Total Budget: EUR 590 million**

**Annual Budget: EUR 147.5 million**

**Authority in charge: Ministry of Agriculture and Rural Development**

The purpose of the program is the financial support of investments for the development and modernization of the food industry.

The main conditions of the scheme are the following:

- **Eligible applicants:** newly established or active enterprises, both SMEs and large enterprises;
- **Eligible types of investment:** establishment of a new unit, the expansion of the capacity of an existing unit, the diversification of the production/activity of a unit, the fundamental change of the production process;
- **The maximum amount of state aid:** up to EUR 57.75 million, depending on the county where the investment is made;
- **The minimum value of a project (without VAT):** minimum EUR 500,000;
- **The maximum intensity of state aid:** between 30% - 70%, depending on the county where the investment is made;
- **Types of eligible investments:**
  - **tangible assets:** constructions, technical installations, machinery and equipment, specialized means of transport - tankers, autoisotherms;
  - **intangible assets:** patents, licenses, know-how, setting up a website to promote and sell your own products; labeling (creating the concept); creation of registered trademark/ brand or geographical indication;
- **There is a list of eligible manufacturing fields of products that can apply for this program.**

## **GD 959/2022 - supporting investments in the manufacturing industry**

**Total Budget: EUR 300 million**

**Authority in charge: Ministry of Economy, Entrepreneurship and Tourism**

The purpose of the program is the financial support of investments in the manufacturing industry.

The main conditions of the scheme are the following:

- **Minimum investment: EUR 3 million;**
- **Eligible types of investment:** Starting a new unit or expanding the capacity of an existing unit and diversifying the production of a unit through products that were not previously manufactured in that unit;
- **Amount of state aid: up to EUR 45 million /project,** depending on the county where the investment is made;
- **State aid intensity: maximum 60% (for large enterprises)** of the eligible expenses, depending on the county where the investment is made (the ranges are between 30% and 60% depending on the county, Bucharest is ineligible). For small and medium enterprises, the intensity will be increased by 20% and 10%, respectively;
- **Eligible beneficiaries: SMEs and large enterprises, which have carried out activity and have at least 3 completed financial years;**
- **Eligible expenses:**
  - **Costs of investments in tangible and intangible assets** (construction of buildings; purchase of technical installations, machines and equipment; purchase of patents, licenses, software, etc., the rental/purchase of land related to the investment)
  - **Estimated salary costs** resulting from the creation of jobs following an initial investment, calculated over a period of two consecutive years from the date of employment;
  - **A combination of a) and b)** not exceeding the sum of a) or b), whichever is greater.

## GD 300/2024 - regional development through big investments

Period: 2024-2026

Total Budget: EUR 450 million

Annual Budget: EUR 150 million

The guidelines for this new program are under construction.

**Eligible expenses:**

- any type of new constructions;
- technical installations, new machines and equipment;
- depreciable assets associated with the initial investment such as patents, licenses, know-how or other intellectual property rights.

The beneficiary must secure a financial contribution of at least 25% of the eligible costs, either through his own resources or through external financing, in a form that is not subject to any other public aid.

The investment must be maintained for at least 5 years after its completion.

The Romanian Government adopted a series of measures to support the business environment affected by the current regional and international context:

- 300 million euros scheme: aid of up to 400,000 euros/company for SMEs with an increase of 15 percent in utility costs;
- EUR 200 million scheme: State aid to stimulate investment of more than EUR 1 million;
- 5.2 billion lei scheme: adjustment of ongoing public investment contracts, financed from national and European funds, depending on the increase in prices for materials, labor, transport, equipment;
- 450 million lei scheme: 75% of the salary for employees in technical unemployment, until the end of the year;
- scheme of EUR 200 million: premium of 10% of the value of processed products for farmers;
- EUR 300 million scheme: working capital grant for farmers.

- water management,
- forest and biodiversity protection,

- sustainable transport,

- support for private sector, research, development and innovation,
- local fund,
- tourism and culture,
- health,
- social reforms,
- good governance,
- education,
- REPowerEU.
