Key vote on Waste Shipment Regulation

The European Parliament's Environment Committee (ENVI) has voted on the draft Waste Shipment Regulation text. Significant measures for the recycling industries include, amongst others:

- Ban of plastic waste exports to OECD and non-OECD countries;
- Stricter measures on environmentally sound management (ESM) in third countries;
- Mandatory recycled content targets for plastics to ensure ESM.

All members of the Europen Parliament are now expected to vote on the ENVI text in January 2023.

EuRIC calls for tougher scrutiny of EPR Schemes

EuRIC has urged policymakers to exercise greater scrutiny before establishing new **Extended Producer Responsibility (EPR) Schemes**.

Often portrayed as a silver bullet to improve waste management, EPR Schemes have significantly multiplied in recent years. In its latest position paper, EuRIC warned that prior to establishing new schemes sufficient assessment of whether a waste stream has a positive or negative value must be made. Moreover, it should also be considered whether alternative policy instruments could be implemented. EuRIC also argues that recyclers or their representatives should be included in the governance bodies of new Schemes.

EU proposes new regulation on Packaging and Packaging Waste

The European Commission has published a proposed Regulation on Packaging and Packaging Waste (PPWR). EuRIC reacted in a press release supporting proposed rules that will mandate the use of recycled materials in new packaging, while expressing its regret over the lack of ambition on recyclability targets.

EuRIC supports Japan's objection to proposed OECD rules on e-waste trade

In its latest position paper, European recyclers have united in support of an objection raised by Japan to new international rules that risk subjecting shipments of non-hazardous e-waste to burdensome administrative requirements.

on REACH-compliance by recyclers

The European Chemicals Agency (ECHA) has raised concerns over recyclers' compliance with REACH. Results from an <u>ECHA pilot project</u> indicate that **26% of checked substances are in breach of REACH**.

EuRIC recently met with ECHA to address these concerns. EuRIC emphasised the efforts of recyclers of all waste streams to produce high-quality recycled materials and presented a solution for EU-wide REACH enforcement of rubber granules and powders derived from waste tyres.

Together with our members from the EuRIC Mechanical Tyre branch (MTR), we are continuing to actively engage with ECHA to help REACH enforcement, which also links with end-of-waste (EoW). You can learn more about EuRIC's engagement with ECHA here.




E-waste Directive

ETS & CBAM

EuRIC joined forces with Sandbag, a non-profit climate change think-tank, to address a **joint letter** urging senior EU leaders to not discourage circularity in the revision of the EU Emissions Trading Scheme (ETS) and the Carbon Board Adjustment Mechanism (CBAM) rules. Sweden to take over the presidency of the EU Council

Sweden is preparing to take over the helm of the Presidency of the EU Council from Czechia on 1 January 2023. The Swedish Prime Minister Ulf Kristersson presented his government's priorities and work programme their presidency. Kristersson noted that Sweden will "prioritise efforts to hasten the electrification of the EU," mentioning the Batteries Regulation — approved by negotiators last week — arguing that Sweden will continue "the negotiations on increasing fossil-free energy production."

The European Commission adopted a recommendation to promote a framework to assess the safety and sustainability of chemicals and materials.

Batteries

Chemicals

The European Chemical Agency (ECHA) has published the draft Community Rolling Action Plan (CoRAP) where substances are listed for evaluation by EU Member States for 2023-2025. Five are planned to be evaluated in 2023, with 19 listed for evaluation in 2024 and 2025. More >>>

POPs

The European Parliament has published a consolidated position on the adoption of a Regulation persistent organic on pollutants (POPs).

Textiles

The European Parliament rapporteur has

reached. The legislation will regulate the entire life cycle of a battery - from production to reuse and recycling - and ensure that they are safe, sustainable and competitive. You can read more on the agreement here.

report argues that producing clothes from recycled bottles isn't "consistent with the circular model for PET bottles." The report also calls for EPR schemes and other measures to "incentivise investment in fibre-to-fibre recycling."

Plastics

The European Commission has published a Communication and Q&A on a policy framework for bio-based, biodegradable and compostable plastics.

E-waste

EU rules mandating a common USB-C charging port have now been published. Manufacturers will have to abide by the rules by 27 December 2024. By that date, Apple will have to make sure its iPhones can be charged via USB-C.

Plastics

The European Environment Agency (EEA) publishes briefing on managing nonpackaging plastics in European waste streams.

Right to repair

Members of the European Parliament's Green political group have tabled questions on the delay in the publication of the Commission's proposal on the right to repair.

New funding opportunities for recyclers available under Horizon Europe 2023 - 2024

The EU has adopted the main Horizon Europe work programme 2023-24, with around €13.5 billion to support researchers and innovators in Europe to pursue breakthrough

- Circular economy solutions for the valorisation of low-quality scrap streams, materials recirculation with a high recycling rate, and residue valorisation towards zero waste;
- Circular economy in process industries: Upcycling large volumes of secondary resources (open to all materials, except plastic waste & composites);
- Recycling technologies for critical raw materials from end-of-life (EoL) products;
- New processes for upcoming recycling feeds (batteries);
- sustainable and safe pre-processing technologies for EOL battery recycling;
- Circular solutions for textile value chains based on extended producer responsibility;
- Increasing the circularity in plastics value chains.
